Apply to surface, then broom or scrub. Allow to stand, till contaminants are dissolved or suspended. It may be necessary to repeat application depending on

the build up.

If applied to a sealed surface, the surface may become damaged and needs to be

re-sealed with Bescon StaSeal® Premium Concrete Sealer.
